Programme Leader for English (14 Jan. 2013 -)	I am responsible for shaping, maintaining, and delivering English at UG and PG level; for its academic and quality standards in terms of quality assurance, student experience, and for the enhancement of learning, teaching, and research. My department achieved 100% Overall Student Satisfaction in the National Student Survey in 2022 and in 2020 (CAH3). It was ranked 1 <sup>st</sup> in the UK for Student Satisfaction in 2022, 1 <sup>st</sup> in the UK for Graduate Prospects in 2021, 22 <sup>nd</sup> in the <i>Sunday Times Good University Guide 2021</i> and 27 <sup>th</sup> in <i>The Guardian University Guide 2021</i> . I led the subject-level TEF and TESOF pilots in 2018 and 2019. I manage the development, organisation, and reviewing of the BA (Hons) English Literature, the English elements of four combined degree programmes (in 2017 and 2022) the MA English Literature and MA Children's Literature and Literacies, which I instituted in 2015 and 2021 respectively. I manage and oversee the standards of the teaching delivery and assessment, pastoral care, engagement, retention, and continuation for the subject. I also liaise with the External Examiner for the subject at UG and MA level. I prepare reports regularly - including the Annual Monitoring Reports and the Response to the External Examiner Report - and control the English budget.	
	I manage a team of two full-time and one fractional members of staff and, an average of three hourly-paid Visiting Tutors per year. I train and mentor the hourly-paid staff members. I directly line manage the English team members who are all HEA Fellows. Recently I supported the promotion to Senior Lecturer of one of them and previously did so for promotion to Reader.

Three decades after the ground-breaking work of critics like Sara Mills, Billie Melman and Reina Lewis, 'Women and the East: Gendered Narratives of Encounter in Nineteenth-Century Writing' brings together eighteen international scholars to reassess and revitalise the gendered and gendering debates associated with the nineteenth-century 'East'. This collection renews an interest in issues of representation as it covers a century of Anglophone literary imaginaries and non-fictional accounts about Eastern Europe, North Africa, the Middle East, India, China, South-East Asia, and Japan. More importantly, the chapters draw on a wide range of thematic and conceptual foci: landscape, race, identity, religion, domestic life. Furthermore, they draw on various critical and methodological approaches – from colonial discourse analysis to postcolonial theory, poetics to the geohumanities, theories of the body and affect to identity politics – to both tackle and critically update formations of gender in relation to sites and lives considered 'other' and 'east' of the nineteenth-century British world. The result is a fresh take on a debate that has ongoing social and critical relevance.

This volume widens the current critique on borders, possibly the most urgent issue in contemporary humanities, by examining their entanglements with dominant constructions of identity and disciplinary categories. It calls into question established models of gender, notions of narrative genres and typological 'genera' of borders in today's literary, artistic, philosophical, and socio-political discourse. The seventeen chapters here collected interrogate boundaries and boundary-crossing not only in terms of geographical frontiers and the physical acts of trespassing, but also as discursive constructs that police crossing subjects as *gendered* subjects, on one hand, and identify artistic genres and academic disciplines as *fixed*, sealed-in ways of understanding the world, on the other. Taking inspiration from the multiple meanings of the Italian word *genere* (which stands for "gender", "genre", and "typology"/"genus" simultaneously), the volume reflects on the gendered, narrative, and typological nature of borders and border imagery, and on the significance and potentialities of crossover phenomena taking place in borderlands, in the fields of arts, literature, anthropology, sociology and philosophy.
